Roseville Police Department: Lt. Kelby Newton

Citizens' Police Academy underway.

Beats 6 and 7: construction theft (appliances, light poles, etc.) frequent, vehicle thefts, theft from vehicles (neighbor home surveillance videos helpful in recoveries—sign up with PDD if you have them).

Construction at water treatment plant (Loren): large dump trucks continue to drive through the neighborhoods despite the main roads being open. Lt. Newton will check with traffic enforcement. Scott Alvord will look into it as well.

J. Middlebrook: Construction traffic on Crawford problematic, near to schools. Question about diverting traffic to main roads (recurring problem).

Personnel changes coming in February. Lt. Newton returning to investigations. New representative TBD.

Roseville Fire Station #9: Jaime Garrett, PIO

Grass fire (2.7 acres) today. Alerted by neighbors who saw the smoke and contained quickly. Started in vegetation on Glenwood Circle adjacent to golf course.

Placer alert system test coming on Thursday, October 15, 2020 at 10:15 am.

November 1, 2020 is daylight saving times. Reminder to neighborhood to check alarms (smoke, carbon monoxide)

Fire Chief Rick Bartee: Fire Prevention Month. Jaime will be putting out safety tips and public service announcements. All firefighters are back in town after agency assists throughout the state. Red flag days coming up due to forecasts. 12 new hires to start as Academy finishes. He said they were grateful that Blue Oaks had opened through to Westbrook Blvd.

Guest Speaker: Derk Garcia, Roseville City School District Superintendent (K-8)

Two presentation sent to Loren: middle school boundaries (June 29, 2020 meeting). Reopening and Remain Open PDF.

Reopening and Remain Open presentation (PDF available): Board meeting on Thursday to look at objective criteria to open schools. State only allows reopening from purple to red. No guidance from other tiers. Dependent on local school districts to reopen. Plan adopted in August by school district. Reopening priorities are:

Health and safe for all students and staff
Student learning and social emotional well being
Supports for minimizing contact (including limitations recommended over holidays)
Fiscal and operational viability

SP98 require in-person instruction but needs to be balanced with health and safety.

Stage I: distance learning for all
Stage II: prioritized cohorts of students, special needs
Stage III: Hybrid model
Stage IV: Full traditional model with enhanced health and safety guidelines

Question for the board on Thursday, October 15, 2020: since Placer regressed, can we bypass stage III and move to stage IV?

The district is asking all parents to do passive screening at home, multiple entrances and exits at each school, report directly to class upon arrival, masks are required for all staff and 3rd-8th grade students, recommended for preschool to 2nd, active screening with digital thermometers, wash in and wash out, limit sharing.

Health and Safety Guidelines:

Clear divider at teacher's desk, clear dividers at the kidney tables to facilitate small groups, face shields with neck are available for staff, recess and lunches in cohorts, students are encouraged to bring their own water bottles (drinking fountains turned off), restroom procedures, Merv 13 air filters in every classroom, additional cleaning supplies, increased testing capacities and contact tracing protocols.

Traditional model back to Distance Learning:

School closure due to COVID-19: multiple cases in multiple cohorts, 5% within a 14-day period

District closure due to COVID-19: multiple cases in multiple cohorts, 25% close due to cases within 14-day period.

Mr. Garcia said his recommendation at the meeting would be for return to school in some measure on Nov. 4th (hybrid or full traditional). If the decision is to return to school, those who wish for their children to remain on home schooling through the Champion program should contact the school district ASAP.

Answers to questions from community:

11,000 students (pre-school to 8th grade), 1,000 employees (500+ teachers)

24% families chose online program (now 26%), 76% chose in-person hybrid model to start on November 4th. (increasing choosing in-person hybrid model)

Derk will present third option that neighboring districts are doing. Will present on Thursday, October 15th.

Question from Julie Middlebrook (resident) regarding Riego Creek Elementary School traffic loop for drop off: We are hopeful that the loop will bypass Crawford and make use of other streets that are designed for this purpose and steer towards Hayden/Holt/Blue Oaks instead of using Crawford. Just want to make sure the routes use Hayden/Holt/Blue Oaks for safety. Mr. Garcia will contact school principal.
